In addition, for the past several years, the group offered an open community Carol Sing and an encore performance of Porgy and Bess for the Summer Arts Festival at Heckscher Park in Huntington. The major works performed during the past season were Messa di Gloria by Puccini and Dixit Dominus by Handel (December 2010) Classical Folks Songs by Brahms, Bartok, Vaughan Williams, and Copland (April 2011).
